Eastern Municipal Water District (EMWD) is willing to provide services to the subject project. Currently, the nearest Eastern Municipal Water District **Water** system is fronting the subject property APN 448-070-011 near the intersection of Myers and Rose Rd and on Rose Rd and Warren Rd. The nearest Eastern Municipal Water District **Sewer** system is located approximately 537 feet west of the subject property APN 448-070-009 at the intersection of Warren and Celeste way. Another of our nearest Eastern Municipal Water District **Sewer** system is located approximately 1,490 feet easterly of the subject property APN 448-070-011 at the intersection of Myers & Devonshire Ave. **Water and Sewer** system improvements would need to be constructed by the property owner/developer in accordance to EMWD's standards, specifications and master plan.

Currently, the District has no plans to construct **Water/Sewer** system improvements in the vicinity of the subject parcel, and they would need to be sponsored by the property owner/developer. Other more feasible alternatives might be considered. The cost of these improvements is unknown and would need to be determined by the contractor/owner. Further arrangements for service from EMWD may also include plan check, facility construction, inspection, jurisdictional annexation, and payment of financial participation charges. The developer is advised to contact EMWD's Development Services Department early in the entitlement process to determine the necessary arrangements for service, and to receive direction on the preparation of facility Design Conditions, which is required prior to final engineering.
