ITEM(S) TO BE CONSIDERED:

Repeal and Restate Chapter 62 [Solid Waste Management] of the City of Hemet Municipal Code: An ordinance to provide a complete and comprehensive set of regulations pertaining to solid waste management within the City. The proposed Ordinance Bill No. 14-038 will apply Citywide, and is entitled as follows:

CITY OF HEMET Hemet, California ORDINANCE BILL NO. 14-038

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HEMET, CALIFORNIA, REPEALING AND RESTATING CHAPTER 62 OF THE HEMET MUNICIPAL CODE [SOLID WASTE MANAGEMENT].

The proposed Ordinance repeals Chapter 62 of the Hemet Municipal Code in its entirety and adopts a revised and restated version which reflects organizational and substantive changes to the Chapter. The proposed Ordinance requires all solid waste generators to procure disposal services from the City's solid waste franchisee, or to qualify for and procure a self-haul permit if the generator is a single family residence. The proposed Ordinance further establishes remedies for noncompliance, and authorizes the City, at the request of the franchisee, to collect certain delinquent refuse charges on the tax roll. The proposed Ordinance also makes organizational changes by consolidating eleven existing articles down to seven.

Revisions and additions to the Code have been made to ensure the Code adequately regulates franchisees and protects public health, safety and welfare. The proposed ordinance is available for review at the City Clerk's office, and on the City's website at www.cityofhemet.org.

This is a public hearing and you are invited to attend and comment on the ordinance described above. As a result of this public hearing and comments, the proposed ordinance may be either accepted as presented, modified, or denied.
