A RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF HEMET, CALIFORNIA, AWARDED A  
PROFESSIONAL SERVICES AGREEMENT WITH BEST  
BEST AND KRIEGER IN THE AMOUNT OF \$40,000 FOR  
REDISTRICTING CONSULTING SERVICES

The City Council of the City of Hemet, California (hereafter referred to as the "City Council") does resolve as follows:

**WHEREAS**, On April 12, the City Council adopted Ordinance 1916, transitioning the City's method of election from an "at-large" system to a "district-based" system.

**WHEREAS**, In 2016, the City held elections for Districts 1, 3, and 4 in which only residents residing within a particular district could vote for their City Council representative. In 2020, the City held elections for Districts 2 and 5 which completed the transition to a by-district electoral system.

**WHEREAS**, The City of Hemet established its district boundaries in 2016, the boundaries are based on the 2010 federal census. Each city with district-based elections is required to update ("redistrict") the district boundaries every ten years, following the receipt of updated population data from the federal decennial census.

**WHEREAS**, Staff is requesting approval of a Professional Services Agreement with Best Best & Krieger for Redistricting Consulting Services in the amount of \$40,000.


