## Sample Letter

### **Re: AB 52 Tribal Consultations for the City of Hemet (SDR 21-021) -JD Fields Project**

To Whom It May Concern:

The City of Hemet hereby notifies you that it is processing a discretionary application, in which the City is responsible for government-to-government consultation with Native American Tribes pursuant to California Assembly Bill 52. The project involves the processing of a site development review, which is subject to the California Environmental Quality Act (CEQA). Therefore, the City of Hemet will prepare an environmental determination pursuant to CEQA for the project.

State law under Assembly Bill 52 (Public Resources Code Section 21080.3.1) allows California Native American tribes 30 days to request consultation regarding possible significant effects that implementation of a proposed project may have on tribal cultural resources. The City of Hemet will begin the consultation process within 30 days of receiving a tribe's request for consultation. The consultation may include a discussion concerning the type of environmental review necessary for the project, the significance of tribal resources discovered, the significance of the project's impacts on tribal resources, and if necessary, project alternatives or appropriate measures for preservation or mitigation that the tribe may recommend.

**Application Numbers:** Site Development Review (SDR) 21-021

**Project Description:** The Project applicant proposes the development of an approximately 25,000 square foot (sq.ft.) metal/prefab modular warehouse building consisting of approximately 22,000 sq.ft. warehouse space and approximately 3,000 sq.ft. office, and 11,961 sq.ft. infiltration basin. The Project would also include approximately 60 parking stalls that include standard auto parking stalls and three accessible parking stalls, including three loading and off-loading truck dock doors, interior drives, 7.0 acres (308,000 sq.ft.) of laydown or outdoor storage facility, six-foot-tall perimeter fencing, and landscaping. The proposed warehouse facility is anticipated to be utilized by the owner/operator, JD Fields & Company, for receipt/delivery, storage, fabrication and distribution of steel/pvc pipe, steel piling, plumbing equipment, valves and flanges.





- **AB 52 Letter Mailed 10/20/2022 for TTM 37558 (800 N Girard Street):**The project includes the subdivision of a 13-acre parcel into 51 lots for the future construction of single-family residences; one lot containing a water quality basin; two lots dedicated to open space, and associated streets, sidewalks, and other infrastructure

improvements. The 51 residential lots would average approximately 8,073 square feet in size. The Proposed Project would change the Project Area's existing zoning of R-2 (Low Density Multiple Family Residential) to R-1-6 (Single Family Residential, 6,000 square feet minimum lot size). The Project Area's General Plan land use designation of Low Medium Density Residential (LMDR 5.1-8.0 dwelling units per acre) would remain the same. The net lot area of the Project area after roadway improvements, open space, and water quality basins is approximately 9-acres. **Location:** The project is bound by Girard Street to the west, Park Avenue to the east, and Menlo Avenue to the south (APN 439-230-005).



- **AB 52 Letter Mailed October 3, 2022 for Zone Change 22-001 & CUP 22-001 for Rally's Burger:** The applicant requests approval to construct and operate a 1,008 square-foot Rally's Hamburger drive-thru restaurant, including site improvements on an 0.75 acre. The project also involves a zone change from M-2 (General Manufacturing) to M-1 (Limited Manufacturing). Restaurants with drive-thru are allowed in the M-1 (Limited Manufacturing) zone, subject to Conditional Use Permit (CUP) approval. The M-1 (Limited Manufacturing) zone is consistent with the General Plan Land Use Designation of BP-Business Park (FAR 0.60) of the General Plan. **Location:** The 0.75 acre property is located at the northwest corner of S Sanderson Avenue and Tanya Avenue (APN 456-050-012)

The Morongo Band of Mission Indians (Tribe/MBMI) Tribal Historic Preservation Office received the City of Hemet (City) letter regarding the above referenced project on October 26, 2022. The proposed SDR21-021 Project (Project) is located within the ancestral territory and traditional use area of the Cahuilla and Serrano people of the Morongo Band of Mission Indians.

Tribal cultural resources are non-renewable resources and therefore of high importance to the Morongo Tribe, therefore, tribal participation (a.k.a. tribal monitors) is recommended during all ground disturbing activities. We look forward to working with the City to protect these irreplaceable resources out of respect for ancestors of the Morongo people who left them there, and for the people of today and for generations to come.

Projects within this area are potentially sensitive for cultural resources regardless of the presence or absence of remaining surface artifacts and features. Our office requests to initiate government-to-government consultation under Assembly Bill (AB) 52 (California Public Resources Code § 21080.3.1) and requests the following from the City to ensure meaningful consultation:

- Currently proposed Project design and Mass Grading Maps

- A records search conducted at the appropriate California Historical Resources Information System (CHRIS) center with at least a 1.0-mile search radius from the project boundary. If this work has already been done, please furnish copies of the cultural resource documentation (ArcMap Shapefiles, reports and site records) generated through this search so that we can compare and review with our records to begin productive consultation.
- Tribal participation (a.k.a. tribal monitors) during the pedestrian survey and testing, if this fieldwork has not already taken place. In the event that archaeological crews have completed this work, our office requests a copy of the current Phase I study or other cultural assessments (including the cultural resources inventory).
- Shapefiles of the Projects area of effect (APE)
- Geotechnical Report

**This letter does not conclude consultation.** Upon receipt of the requested documents the MBMI THPO may further provide recommendations and/or mitigation measures.

The lead contact for this Project is Bernadette Ann Brierty, Tribal Historic Preservation Officer (THPO). MBMI Cultural Resource Specialist Laura Chatterton, will be assisting the Tribe in the review of this project.
